THE WSJ'S EDITORIAL PAGE HAS FACED CRITICISM FOR PERCEIVED POLITICAL LEANINGS, WHICH SOME ARGUE COULD INFLUENCE THE FRAMING OF BUSINESS NEWS AND ECONOMIC COMMENTARY. WHILE THE NEWS REPORTING DIVISION MAINTAINS JOURNALISTIC STANDARDS OF IMPARTIALITY, IT IS IMPORTANT FOR READERS TO DISCERN BETWEEN EDITORIAL OPINIONS AND NEWS CONTENT.

ACCESS AND AFFORDABILITY

THE SUBSCRIPTION COST, WHILE REFLECTIVE OF QUALITY, MAY LIMIT ACCESS FOR SOME DEMOGRAPHICS, POTENTIALLY NARROWING THE AUDIENCE TO PROFESSIONALS AND AFFLUENT READERS. THIS RAISES BROADER QUESTIONS ABOUT THE DEMOCRATIZATION OF FINANCIAL NEWS AND INFORMATION EQUITY.
