THE IONIAN SCHOOL, WHICH INCLUDED ANAXIMANDER AND ANAXIMENES, FURTHER DEVELOPED THESE IDEAS, CONTRIBUTING TO COSMOLOGY, METAPHYSICS, AND NATURAL PHILOSOPHY. THIS ERA LAID THE GROUNDWORK FOR LATER THINKERS BY EMPHASIZING OBSERVATION AND REASON.

CLASSICAL PHILOSOPHY: THE RISE OF METAPHYSICS AND ETHICS

ARISTOTLE'S EMPIRICISM AND SYSTEMATIC PHILOSOPHY

ARISTOTLE, PLATO'S STUDENT, DIVERGED BY EMPHASIZING EMPIRICAL OBSERVATION AND CATEGORIZATION. HIS WORKS ON LOGIC, METAPHYSICS, ETHICS, AND POLITICS FORM THE BACKBONE OF MUCH WESTERN PHILOSOPHY. MEDIEVAL PHILOSOPHY: OCKHAM AND THE SHIFT TOWARD NOMINALISM

MEDIEVAL SYNTHESIS AND THEOLOGICAL DEBATE

THOUGH MEDIEVAL PHILOSOPHY IS OFTEN ASSOCIATED WITH THEOLOGICAL CONCERNS, IT ALSO GRAPPLED WITH LOGIC, ETHICS, AND NATURAL PHILOSOPHY. THINKERS LIKE THOMAS AQUINAS SYNTHESIZED ARISTOTELIAN PHILOSOPHY WITH CHRISTIAN DOCTRINE, WHILE OCKHAM'S CRITIQUE PAVED THE WAY FOR MORE SECULAR AND SCIENTIFIC APPROACHES.
